Between _____ (Hereinafter referred to as the Artist), residing at (your address) and Picket Fence Art Studio; whereas the Artist is a professional artist of good standing, and wishes to exhibit artworks through PFA Studio; and whereas PFA Studio wishes to exhibit artworks by the Artist under the terms and conditions of this agreement.

Therefore, the parties hereto agree as follows:

_____ 1. **Loss and Damage:** The Artist will be responsible for loss or damage to their artwork from the date of installation of the exhibit until removing the artworks at the end of the exhibit. PFA Studio and the exhibit location are not responsible for any loss or damage of artwork.

All artwork to be delivered to PFA Studio by May 16th at 12:00 pm.

Plan on picking up any unsold artwork on Sunday, May 18th at 5:00 pm.

PFA Studio is not responsible for any loss or damage caused during the unloading, installation, and presentation of the art.

The Artist is responsible for insuring their artworks during the exhibit.

_____ 2. **Terms and Termination:** This agreement is valid from the date of signing and may be terminated by either party at any time. This agreement will automatically terminate with the end of the exhibition or earlier if the exhibit space closes.

_____ 3. **Exhibitions:**

All artwork to be delivered to PFA Studio by May 16th at 12:00 pm. Art work must be ready to hang with a wire across the back.

Artwork must be labeled with:

- The Artist Name
- Name of the Art
- Medium, Size
- Price if it is for sale.
- Contact information for sales

Artist is encouraged to attend and invite friends to the Opening Reception May 17th at 6:30 pm.

_____ 4. **Commissions:** PFA Studio will charge a 35% Commission for art sales.

Delivery of sold artworks is the Artist's responsibility.

_____ 5. **Arbitration:** All disputes arising under this agreement shall be submitted to binding arbitration before a suitable arbitrator and the arbitration award may be entered for judgment in any court having jurisdiction thereof. Either party may refuse to arbitrate when the dispute is for a sum of less than \$1,000.

_____ 6. **Governing Law:** This Agreement shall be governed by the laws of the State of Washington. In witness where-of the parties hereto have executed this agreement of the day and year above set forth.
